 - b) The certificate from CFO or the person responsible for financial management to the effect that the funds disbursed for CSR activities have been utilised for the purposes and in the manner as approved by the Board for the CSR spent by the Company during the year 2022-23, was not obtained or placed before the Board;
 - c) The Company has not prepared Annual Action Plan on CSR;
 - d) The Company has not hosted on its website the details of CSR Committee and CSR Projects; and
 - e) The Board has not reviewed the projects for which CSR amount was approved by it.
